Job description and Location: A Nanny is doing the same job as an au-pair but on full time from Monday to Friday. Often does the family already have an au-pair but want a supplement. The families are located in the whole of Denmark and sometimes in the EU for our Engineers, Pharma and IT persons who is working for us por are asking us through the networking we deliver to. We deliver to the biggest companies in EU. You must be English speaking, The work is to take care of kids, cleaning, ironing, and eventually cooking and shopping for the family. It's a benefit with driver license. The families consist of a couple and 1 to 3 kids. Mostly they live in a Villa, and the conditions are according to the FASTTRACK rules of <https://star.dk> which is the authority.

The expenses (paid by the family): The family pays 2 flight tickets, one from the home country and 1 to the exit country, once the contract is expired (most often Europe). If the Nanny gets another job in Denmark, then it is not to be paid.

The salary and educational demands: Any contract can be re-negotiated after 2 years and you can have a NANNY unlimited usually. The Nanny should have what is similar to 9. Class in Denmark. Often, they have an education as Nurse or similar. You are paid minimum 19.660 kr. monthly including accommodation and all meals every day. We are paid 4.500,- by the family, why there is NO COST for the Nanny to get the job, sending a CV or job interviews. If the Nanny needs a VISA and/or Working Permission – the cost is 2.850,- or 1.875,- pr. Hour.

The working time: Working time is 37-40 hours pr. Week from Monday to Friday. Work over that time is paid by extras after 18:00 – see www.3f.dk The Nanny are entitled to at least 6 weeks of holiday each year. In addition, the Nanny are entitled to take the day off on official Danish public holidays.

Age restriction: For the Nanny you must be a minimum of 18 years at the arrival in Denmark. You can come from another EU country or outside EU, such as Philippines, Thailand, China, Africa etc.
